### Product description

Rhenofit® CNT-2 is a water based suspension of multiwall carbon nanotubes, which can be used directly for production of formulations. The suspension is stabilized; the employed carbon nanotubes are dispersed and the suspension is highly homogeneous. The applied process ensures non-destructive dispersing of carbon nanotubes in mild conditions.

### Composition:

Composition: 2 wt% single wall carbon nanotubes

2 wt% dispersant agent in water

Appearance: stable black suspension

Odour: no odour

Compatibility: can be mixed with liquid systems and some polar organic solvents

Amount of CNT = 2 wt%,

dry content = 4 wt%

pH Value 8,8




Image of Rhenofit<sup>®</sup> CNT-2 from Transmission Electron Microscope

## Application

Possible applications include, but are not limited to, latex, rubber, coatings, paints, as well as construction and energystorage

## Storage behaviour

The storage stability of Rhenofit<sup>®</sup> CNT- is guaranteed for at least 6 months in closed original tins at temperatures exceeding 10°C.

## Handling

Please follow the instructions in our SDS.

Rhenofit<sup>®</sup> CNT is a ready to use dispersion, we recommend the following procedure:

- We recommend to stir Rhenofit<sup>®</sup> CNT before use
- Dilute Rhenofit<sup>®</sup> CNT with the pre-mixed formulation (order might be important)
- Try to avoid to dilute Rhenofit<sup>®</sup> CNT with de-ionized water
- pH value can be raised with NH<sub>3</sub> or KOH -solution to adapt to formulation if suitable

Emission of nano particles are very unlikely, if drying of the product is prevented. In the case of risks of dust emission we recommend to respect to inhalation toxic substances, cat. 1 (worst case) by doing the job safety analysis and definition of PPE at the work place.

We recommend to use air-tight bags and folios as packaging material for rest amounts, spilled products and absorbed material. These packaging should be strictly unopened got through the supply chain of disposal ideally transferred directly to waste incineration.
